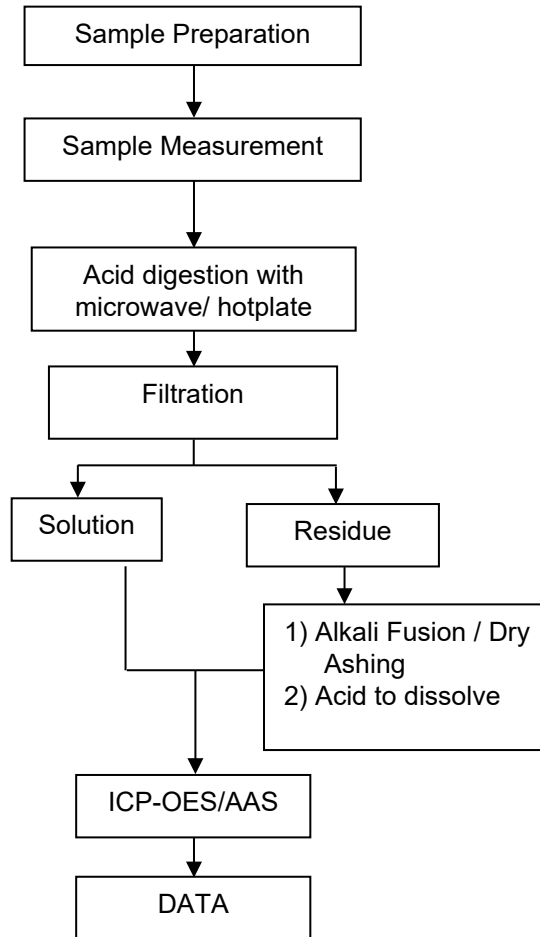

Elements Testing Flow Chart

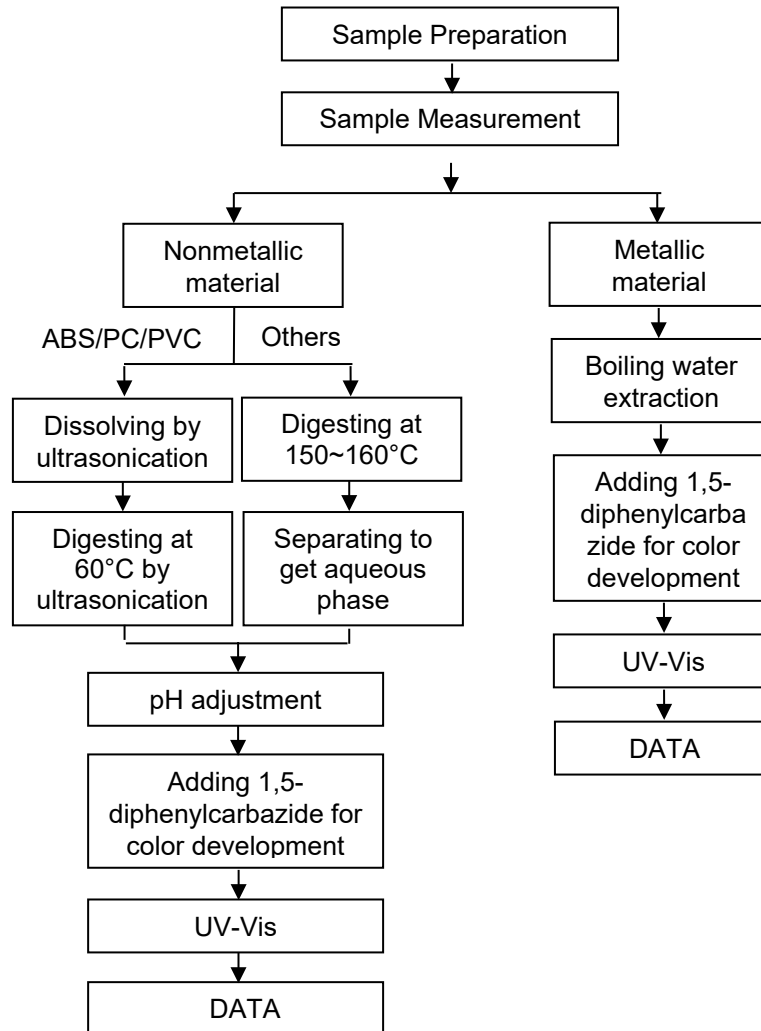

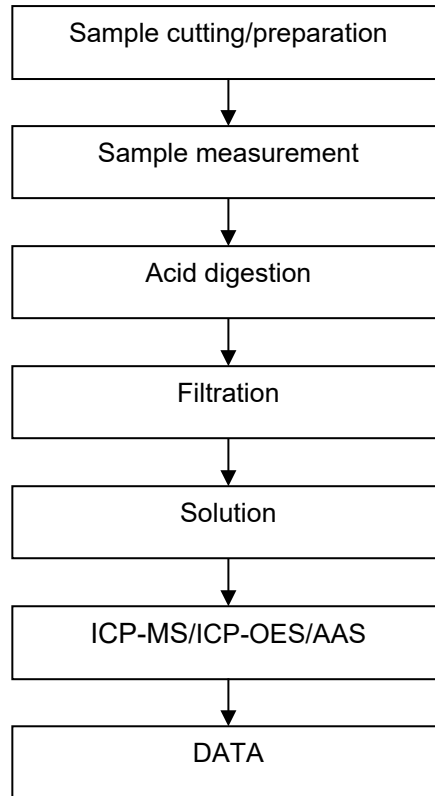
PBB(s)/PBDE(s)/Phthalates Testing Flow Chart

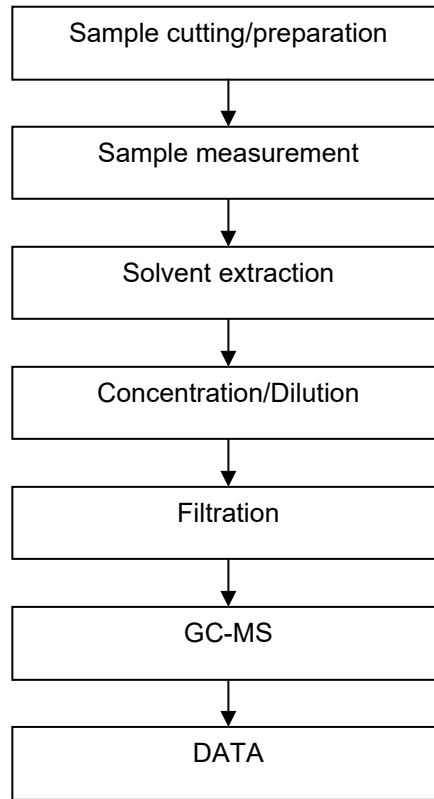
Elements Testing Flow Chart

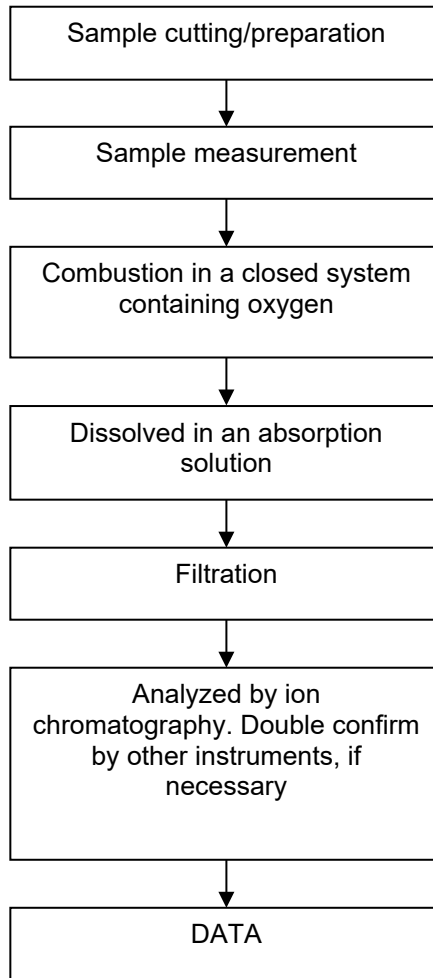
HBCDD Testing Flow Chart

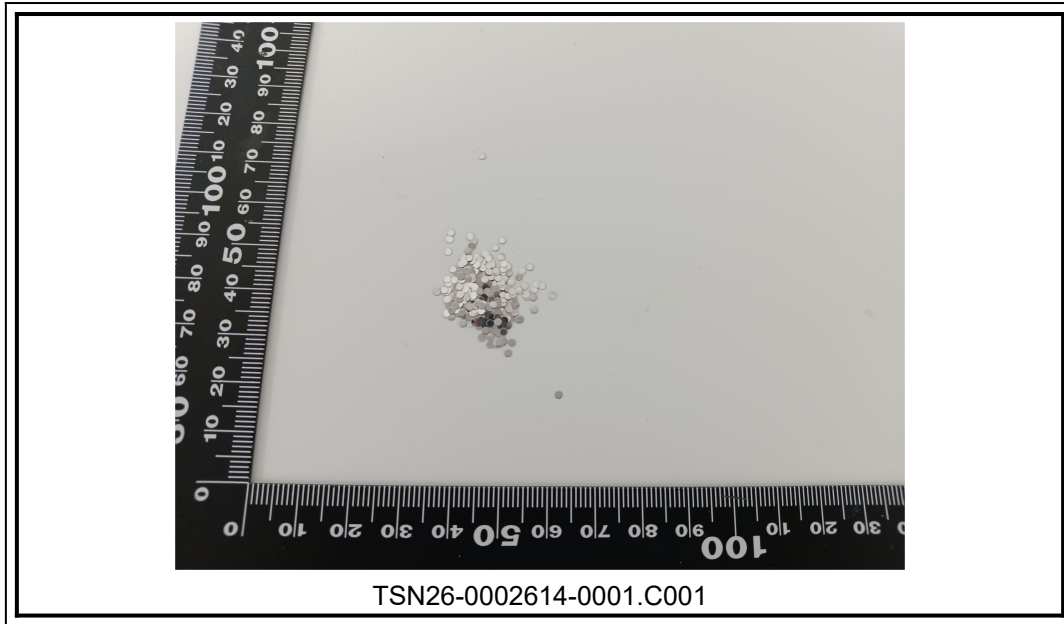
